3. Valid Pakistani Passport and NIC: Original with two copies each. (Only name, photo & validity Pages of Passport)
4. Old Pakistani Passport on the strength of which the applicant travelled from Pakistan: Original with two copies. (only name, photo & validity pages of Passport)
5. Coloured photographs of 2" X 1.5" with light blue background (enclosed in an envelope): Eight (08)
6. Processing Fee US \$ 10/= & Fee for cancellation of NIC/CNIC/NICOP (US \$ 100): To be deposited in Habib Bank Limited, Koinange Street Branch, Nairobi.
